



## Boston Scores Leadership Council

The Boston Scores Leadership Council is comprised of a select group of forward thinking community leaders who support Boston Scores. Members are advocates for the organization and play an integral role in Scores' development efforts.

Working with Scores' Director of Philanthropy and Leadership Team, this group deepens our impact by building on the strong financial foundation of the organization. Memberships are based on a calendar year and are reviewed annually at the Board's Annual Meeting in January.

The Leadership Council also serves as a candidate pool for new Board members and as a vehicle for previous Board members to remain involved with the organization after their Board terms expire (members who previously served on our Board are invited to attend Board meetings as non-voting participants).

### **Expectations**

**Fundraising:** \$1,000 minimum annual "give/get". Donations may be made directly, as part of an event or by securing support from another person, company or foundation.

**Engagement:** Serve as an active supporter of Scores' development efforts by communicating with and engaging others in supporting the Scores mission (attending events, volunteering, making introductions).

**Committee Service:** All Leadership Council members are encouraged to participate in at least one Board Committee. Committees eligible for Leadership Council membership include: Development Committee, Scores Cup Committee, Scores Celebration Committee, and One Hen Celebration Committee.

**Meetings & Communications:** Members of the Leadership Council are invited to join the Board at its annual Board Retreat (typically on a Saturday in May or June) and receive twice a year briefings from the Boston Score Leadership Team (typically over the winter and during the summer) outlining the organization's goals, progress and challenges. Leadership Council members have access to meet with or ask questions of the Leadership Team throughout the year.

### **Ways to Engage as a Leadership Council Member:**

- Advise Leadership Team on strategic and operational issues
- Visit the program or volunteer
- Join a Board Committee
- Introduce Scores to your company (sponsorship, employee engagement)
- Host a house party
- Buy a "table" at one of our events or secure a sponsorship for the event
- Introduce friends and business partners to Scores
- Identify other Leadership Council members
